Items. Our Liberty Furnace corespondent furnishes us with the following: On last Friday night between 8 and 9 o'clock, the Chirstly Mumaw property, dwelling

house near Cabin Hill burned down. On last Saturday quite a commotion was caused in the congregation of St. Paul's Church near Liberty Furnace, Whilst Rev. sermon, by someone, standing in the doorway, calling out "Jacob R. Miller's house is on fire." The congregation immediately departed to the scene of the conflagration about a half mile distant. On their arrival, it was discovered that the dry house and bake oven were burned down, as well as part of the garden fence. After the fire, the congregation repaired to the church where the sermon that had already begun was finished.
