Oct. 17, 1884

A terrible conflagration broke out in Mt. Jackson about 12 o'clock Thursday night, and continued until about 3 o'clock Friday morning. Terrible fire at Mt. Jackson. The fire originated in the store of J. W. Miller & Co., but the cause is not known. Whilst the store of J. W. Miller Co. was burning, the fire communicated to the agricultural warehouse of Jno. P. Lonas, on the opposite side of the street. About the same time the property lately purchase by Mrs. Ella Hammond and sisters. Misses Rebecca and Alice Rinker, took fire and was consumed. A store room on the same lot, occupied by Mrs. Dr. Jones, as a millinery establishment was burned. A store building, adjoining the property of J. W. Miller & Co., occupied by W. O. Towns & Co. as a drugstore, and the upper store of which was occupied by R. A. Lemley as merchant tailor was consumed.
