copal pastor, &c., and adds:

"Unquestionably he was a Lutheran minister. Rev. Paul Henkel, a co-laborer in the Lutheran Church, often recited the incident to some of our oldest citizens. Whilst some, with the author, represent the event as taking place at Woodstock. Va. (then Millerstown), there is a stronger probability that it took place near Rude's Hill, about four miles north of New Market, Va. The church in which is supposed to have taken place is no longer standing. We make the corrections only as a matter of history. The gown worn in those days by Rev. Paul Henkel is now in the possession of his grandson, Rev. S. Henkel, D. D., of this

Rev. Peter Muhlenberg was a Lutheran

minister, but he went to England and received Episcopal orders. The Editor of the Valley can find the matter fully explained in the life of Rev. Peter Muhlenburg. We know not upon what authority, the Editor of the Valley bases his stronger probability, but we can refer him to an old gentleman of this neighborhood who conversed with a gentleman who was present when Rev. Peter Muhlenburg delivered the famous sermon in the old church that stood on the Episcopal lot in this town near the location of the new Episcopal church.
