Mt. Jackson News. Mr. J. W. Pence of Sweetze, Indiana, formerly of Hawkinstown, has recently returned to Shenandoah County as agent to set in motion and carry on the Murphy Temperance cause. When Mr. Pence left the Valley some 12 years ago, he was known as one of the worst drunkards of the Valley...four years ago by the grace of God, he was rescued.

Mr. Mahlon Miller, an inmate of the county almshouse, aged about 45 years, underwent a very difficult and extensive surgical operation. Mr. Miller had both feet frozen during the war, from the effects of which he never recovered, but continued to grow worse as necrosis of the bones supervined, causing gangrene. Dr. D. D. Carter performed a Chopart's operation, being the removal of all of the bones of the foot except the heel, and covering the end of the stump with the tissues of the bottom of the foot.
