Death of a Stranger. As shown by the hotel register, Mr. Alph. Settle from Flint Hill, Rappahannock County, came to the Central Hotel in New Market Dec. 6, 1881. He came for the purpose of receiving medical treatment from the Drs. Henkel. A careful examination disclosed the facts, that the patient had a stone of the bladder... a surgical operation inadvisable. Mr. Settle died Dec. 30, and was buried in St. Matthew's graveyard. An effort was made to inform his friends of this event but so far there has been no response. We judge Mr. Settle was a man of 55 or 60 years of age.

On 1<sup>st</sup> of Jan. in Powell's Fort by Elder Wm. Peters, Mr. Manoah Harman to Miss C. Moreland, all of this county.

Died. On 21<sup>st</sup> of Dec., Harry C., infant son of Mr. And Mrs. D. H. Hottel, aged five months.

In Woodstock on the 8th of Jan. Mrs. Emma Keller, wife of Mr. John L. Keller and daughter of Moses Walton, aged 24 years. She had been married but a little more than one year and left an infant but two weeks old.

In Strasburg Jan. 10th, Burtram McInturff, infant son of A. P. and Anna McInturff, aged 21 months.

Small Pox. A case of small pox has occurred on Stony Creek five miles above Edinburg. Mr. Wm. Larkins had been boarding at a house in Pennsylvania in which there was small pox. Ten days after his return, he broke out with small pox.

Small Pox. Mr. William Larkins, the man who brought the small pox to this county, died at his residence on Stony Creek and was buried by his nurse. Mr. Day, who was at the home of Mr. Larkins, wore an overcoat before it was known he had small pox, and also has the disease.
