He has to drive very slowly on account of being overloaded. His rules for going up a hill are as follows: First class passengers keep your seats, second class passengers get out and walk, third class passengers get out and push.

New Post Master. M. M. Campbell was appointed post master at Lantz's Mill and W. A. Borden at Harrisville.

July 22, 1897

Died. Mr. Daniel Mowery July 14th aged 77 years.

"Aunt Liza" Taylor at her home in New Market July 21, her age being given by some at 86, and others at 90 years. She was married several times, her last husband being Henry Taylor, who died here about twenty-two years ago, and leaves three children: Sarah Jane Jasper in Rockingham county, Amanda Jones in this place, and Catharine Willis in Philadelphia. Aunt Eliza belonged to the Graves estate in Madison county, and was then sold to Mr. Harvey Strickler, now deceased, in Page county, where she lived for some time; and then to a man in Richmond. Being badly treated, she ran away and walked to Linville, Va., where she stayed until after the war, when she moved to New Market, and lived with Miss Harriet Litttell for a number of years. She accumulated some property-a house and lot of her own.

St. Luke News. Mr. William Peters from near Mt. Jackson, and Messrs. Abraham & Noah Zirkle of near New Market were here for the funeral of their cousin, Mr. Mowery.

Conicville News. The sad news of the death of Mr. Frank Kagey reached our

village last evening. His wife is also very low with the same disease, typhoid fever. Mr. Kagey was the son-in-law of Mr. I. D. Good...Some one came to stay the Mr. C. F. Dellinger's a few days ago. It is a little girl and a welcome guest...Mr. P. C. Dellinger, one of our oldest citizens, is very low, and not expected to last much longer.

A Fatal Shot. A startling tragedy occurred at the residence of Mr. Daniel E. Stickley in Strasburg Wednesday. Mrs. Sallie H. Kramer, a beautiful and charming young widow, who was visiting at Mr. Stickley's, either intentionally or by accident, shot herself and died at 11 a.m. She was the daughter of Mrs. Ann Hupp.

Died. George Strother, colored, at his home in New Market, July 27. He leaves a widow, one son and two daughters. His daughters, Mrs. Sarah Johnson and Mrs. Noble Johnson, both of Oil City, Pa., attended the funeral. He and his family moved to New Market from the Williamson homestead several weeks after the surrender, where he has ever since resided. The deceased was formerly owned by the late Daniel Zirkle, but at the abolition of slavery was the property of the Soxman estate, and was popularly known as George Soxman.
