

This postcard photo of court square in Woodstock is dated 1914. According to the message on the back, it was sent in response to a lefter that arrived in Quicksburg "on the two o'clock train," The photo was taken soon after the new jail was built and enclosed in an iron fence and before the front porch was added to the courthouse. A monument then stood in West Court Street near the front of the courthouse. The building adjacent to the jail (far left) housed the sheriff's office and the sheriff's personal residence. Shenandoah County required that its sheriff and his family live at the jail until the 1960s. Soon thereafter, a new jail was built and the sheriff was allowed to live where he chose.
