Needmore Items. We are sorry to say that Mr. Daniel O. Bowman died on last Thursday from injuries inflicted by a horse...Miss Maggie McInturff has been unable because of illness to teach her school for the past week. She is the teacher of the school at Hoover's River Bend School House...On last Saturday night Mr. Samuel Hottel had a corn shucking which was the first in this section and I guess will be the last on account of the flood which swept the splendid corn crops out of the river bottoms.

Dec. 11, 1896

Capt. S. H. Bowman has purchased the old school building situated on the corner of Court and Muhlenberg streets in Woodstock for \$1,160, He proposes to convert this building into a business house. Court street is looking up and will soon rival Main street as the business portion of the town. It has now one furniture factory, one drug store, two restaurants, one hardware store, one jeweler, and book store, one meat store, two barber shops, Treasurer's office, County Clerk's office, one lawyer's office, one dentist's office, one harness factory and store, one furniture and notion store, two public halls and the hall of the Masons, Odd Fellows and Junior Order of United American Mechanics, one cigar factory, one agricultural implement store, and the office of the Shenandoah Herald. This street runs from the railroad station across Main street to Water street. French's steam roller mill is only a few feet from the eastern terminus of this street.

An Unsuccessful Effort to Lynch Weatherholtz Elmer Weatherholtz was undergoing trial in our county court upon the charge of assault with intent to kill Mrs. Biller, his mother-in-law...On Saturday morning about 10 o'clock there was a knock at the jail door, to which Mr. Wenger, the jailer, answered...Mr. W. opened the door and found a number of masked men before him and six pistols thrust into his face...he explained to them that Weatherholtz...had been removed...they quietly examined the jail and retired...sheriff Wightman had removed Weatherholtz from the jail to the clerk's office because he suspected that there might be an effort to take him ...

Mr. John Clinedinst, near Edinburg, was severely cut on last Friday night. It is charged that the cutting was done by Mr. Elijah Looker. The difficulty occurred at a raffling match at Joseph Rush's and arose in a dispute about three cents change. Mr. Clinedinst's injuries are reported to be very serious.
